ENVIROLINE ACRYLIC WHITE LINE PAINT

DESCRIPTION

ENVIROLINE is carefully formulated with 100% acrylic emulsion for use on tennis courts, running tracks, basketball courts and other recreational areas. The use of ENVIROLINE results in clean, clear-cut permanent lines. ENVIROLINE is designed to give superior lines on all types of asphalt and acrylic surfaces and are recommended for use over all Environmental Sport Coatings systems. ENVIROLINE is available in white and all ten of our standard EnviroCoat colors.

USE

Tennis courts, running tracks, basketball courts, asphalt, and other recreational areas.

COLORS

White · Yellow · Dark Green · Light Green · Dark Blue · Light Blue · Red · Dark Red · Burgundy · Tan · Brown · Gray

SURFACE PREPARATION AND APPLICATION

New asphalt must cure for 14 days under normal summer drying conditions, longer during cooler weather and be clean and free of all grease, oil, dirt and any other foreign matter. Clean by washing with a high-pressure water hose or blow clean with an air broom. Remove any grease or oil with a strong detergent and then flush thoroughly with water.

DRYING TIME

One hour under optimum outdoor temperature and humidity conditions. Always allow coat to thoroughly dry to it's full depth before application of subsequent coats.

IMPORTANT

Allow a minimum of 24 hours drying before playing on newly surfaced areas. Do not play on surface when wet for a period of thirty days after the application of coatings.

DILUTION

Apply as is with brush or roller. For spray application add up to 20% water.

COVERAGE

Coverage is approximately 480 lineal feet of 2" lines per coat, per gallon. One gallon per tennis court is usually sufficient for one coat.

NUMBER OF COATS

Two coats recommended.

LIMITATIONS

Do not apply when surface temperature is below 50° F (10° C) or when rain or high humidity is imminent. Do not apply if surface temperature is above 130° F (55° C). Always allow coat to dry thoroughly before application of subsequent coats. Keep containers tightly closed when not in use. Keep from freezing. Do not store in direct sunlight.

CLEAN-UP

Remove all spilled material immediately. Clean all equipment with water immediately after use.

CAUTION

Do not take internally. Keep out of reach of children.
